This workshop will open with presentation of 4 ethical decision-making models. The main focus of the talk will be application of ethical decision-making models to case examples related to current hot topics, specifically working with clients who are trans &/or

gender nonconforming and clients who are considering seeking an abortion. Learning Objectives:

- 1. Describe Koocher and Keith-Spiegel's (2016) model for making ethical decisions.
- 2. Identify non-rational processes that may impact ethical decision making.

3. Describe how Sue and colleagues (2009) model cultural competency in psychotherapeutic interventions applies to ethical clinical practice with clients who are transgender and gender diverse.

4. Apply material from the workshop to promote resilience and coping with transgender and gender diverse clients.

5. Describe how recent changes in the law related to abortion may create a conflict with psychologists' ethical responsibility to maintain confidentiality.

6. Apply material from the workshop to support the well-being of clients who may be

considering an abortion.

Dr. Campbell is a professor in the Counseling & Human Development Department at UGA and the Director of the Center for Counseling which is the training clinic for doctoral students in Counseling Psychology.

Dr. Campbell serves as Vice-President of the Georgia Board of Examiners of Psychology and is the Chair of the APA Ethics Code Task Force to revise the APA Ethics Code. Dr. Campbell is first author of the APA Ethics Code Commentary and the more recent Casebook on Telepsychology. She has authored numerous texts and books chapters in the area of ethics and is an associate editor of Practice Innovations. She was Co-Chair of the APA Telepsychology Guidelines Task Force and Co-Chair of the APA Assessment and Evaluation Guidelines. Additionally, she is a past chair of the APA Board of Education and the APA Ethics Committee and was a member of the APA Board of Directors from 2014-2016. Dr. Campbell is a native of West Virginia and lives outside of Atlanta near Athens with her husband Alan and their Cavalier King Charles, Maggie.

The Evolution of Ethical Practice

The workshop will offer an overview of the APA Ethics Code revision and discuss contemporary challenges to ethical practice. Technology, research methods, and the importance of cultural competency are among the areas of significant impact for ethical practice. The workshop will identify and discuss the Ethics Code

. revised principles which include Justice and Social Justice and Human Rights and Civil Rights. The newly proposed revision to the standard on unfair discrimination will be identified. Applications of revised standards in Research and Technology that identify nondiscriminatory practices will be discussed. Other aspects of diversity introduced in other sections of the proposed Ethics Code will be discussed.

- 1. Identify major areas of revision of the APA Ethics Code,
- 2. Describe the areas of technology that newly apply to ethical practice,
- 3. Describe the advances in data collection and retention that apply to psychological research,
